1. I have read, understood and accepted without reservation the ADN RACE Ponta do Sol regulation, which will be held on 17<sup>th</sup> of September 2017, whose regulations and all information are published on the official website of the race ([www.adnrace.com](http://www.adnrace.com)).
2. I am physically and psychologically prepared to participate in the ADN RACE Ponta do Sol (whose information I consulted in advance on the official website of the race) and to complete it within the established time limits, having a perfect notion of the physical and mental difficulties inherent to the course, altimetry, and distance of the race that I will participate, such as extreme fatigue, digestive problems, joint and muscular pain, and others.
3. It is my responsibility to have a valid medical certificate for the practice of sport and that I do not know any impediment of a physical and psychological nature, not suffering from any disease, allergy, injury or other, that makes my participation in the ADN RACE Ponta do Sol impossible.
4. I acquired a real mountain self-sufficiency before the race, which allows me to manage the problems caused by this type of race, especially in terms of changes in the weather conditions (night, wind, cold, fog, rain or snow ), as well I have the ability to be autonomous between two checkpoints, not only in food but also in clothing and safety.
5. I have all the mandatory equipment foreseen in the regulation of the event, in perfect conditions of use, and I assume the commitment to use and/or transport this equipment throughout the race, being aware of its correct handling and use.
6. I accept the rules and safety protocols established by the Organization of the event and I will adopt a responsible behavior, avoiding actions that may endanger my physical integrity and others. I further undertake to follow the instructions and to accept the decisions that may be taken by the Organization with regard to security matters.
7. I authorize the medical team of the event to perform in me any medical procedure or diagnostic test that is necessary during the race, whether or not requested by me, submitting myself to their authority and accepting their decisions that may be disqualification ( in the case of being considered incapacitated to continue in the test), hospitalization (in the case of the health state so requires) or evacuation (in case of being in danger of health).
8. I authorize the recording of images from my participation, permitting that the Organization can use them in the advertising and promotion of the event on any medium, giving to the Organization all the image rights related to the use of those images.
9. I will not consume before or during the event substances prohibited by the regulation and by the legislation in force, being aware that anti-doping tests may be carried out.
10. My registration is personal and non-transferable, so I can not assign or sell to another person under any circumstances.
11. I am aware that this type of races carries additional risks for the participants, so my participation is entirely my responsibility and cannot input to the organization, its volunteers, sponsors or other participant, any criminal or civil responsibility, for any physical, moral or material damages that occur during the event, in which I might be directly or indirectly involved, that exceed the insurance coverage of the event.
12. I fully accept the principles of safety, respect for Nature, agricultural areas, public and private property, as recommended in the regulation of the event.
